Mrs. Morales-Hanley stated that there are not many changes to the athletic budget but would like to come up with a better process/schedule for the rotation of purchasing new uniforms for each sport.

# **Discussion: Transportation Budget Draft**

Mrs. Morales-Hanley noted the fuel bids that came in last week with diesel at an increase of 10¢ and a fuel increase of 17¢. Mrs. Morales-Hanley also discussed the need for 3 new buses to maintain the 7 year rotation of bus purchases.

Mr. Rice discussed his great team of bus drivers and noted no reportable accidents or incidents. Also noted was the upcoming seatbelt law, DOT inspection changes and trade in values of buses.

### Discussion: 2019/2020 Budget Draft

Mrs. Morales-Hanley noted that although the budget is preliminary, several meetings have been had to fine tune numbers and that the BOCES numbers are all estimates. Final budget numbers will be determined once the state budget has been released. Mrs. Morales-Hanley also noted a discussion with fiscal advisors stating that bus purchases can start being paid with cash from the general fund instead of bonding, causing an increase in the tax cap. The BOCES Capital Project line increase was also noted. The March meeting should indicate better budget numbers.
