Mrs. Sykes discussed the June Regents' examination results, along with the A.P. exam results for AP Biology, AP US History, and AP European History. She noted this is the last year we will teach AP European History. She noted students received college credit in AP Biology and AP US History, but unfortunately no one received credit for AP European History.

Ms. Hughes noted that the ELA and Math examination grades are not yet in. She discussed changes being considered for the awards ceremonies for next year and the update to the elementary handbook for next year. She also discussed ramping up the rigor for the common core curriculum.

Mr. VanBrocklin left the meeting at 7:41 P.M. Vice-President LaPoint assumed the chair.

Ms. Kelly inquired if anyone would be attending the King & King dinner meeting regarding funding for school projects. She discussed the possibility of hiring an LPN for the nurse's office, as the teacher's assistant and clerical assistant are being removed from the office for next year. She discussed the many state mandates required, the number of serious illnesses the school nurse deals with (type-1 diabetes, epi-pens, asthma inhalers, etc.), in addition to the many daily medications being dispensed. We have discussed this last year and have a pool of 25 applicants from our previous search. Ms. Kelly proposed hiring an LPN, who can administer meds under the directions of the RN and she proposed a \$15/hour salary to the board members. Mr. Averill asked Mrs. Phillips is we have money for this and she indicated that we had a teacher retirement that was not planned for and therefore the money is in the budget. She also noted that we are not filling the part-time Spanish position due to a lack of applicants and the concept of using a computer-based course for Spanish IV. Mr. LaPoint asked if we had asked another school to share a Spanish teacher and Mrs. Sykes noted she had asked all neighboring schools and no one had a position to share. This will affect eight students and it is not required for college or for a Regents' diploma. Ms. Kelly noted that it will cost approximately \$4,500 for all eight students to take the on-line course, which is monitored by their instructor. Mr. Coller asked why schools can't coordinate their bell and class schedules and it was noted that this is driven by individual contracts in each district.

It was noted by Ms. Kelly that there will be two meetings in August due to hiring staff and the openings of the bid documents. She discussed the special education opening and that three of the cour applicants were not certified. We will probably re-advertise this position. The Maintenance/ Transportation position has three applicants, but two of them have no maintenance background. The third applicant is extremely qualified, but may not be in our salary range. It was noted that our current Buildings & Grounds supervisor's salary will be partially transferred to the building project as he takes on the Clerk of the Works position and this employee does have the caliber of skills to replace him when he retires down the road. The committee will interview him and report back to the Board.

Mrs. Phillips noted that there is a statewide consortium asking boards to approve a GEA resolution. The resolution asks for an end to the GEA (Gap Elimination Adjustment). Our district has lost \$2,323,993 since the implementation of the GEA.

Whereas: This cost shift has resulted in unsustainable measures being implemented to balance the Edwards-Knox Central School's budget, including the reduction and elimination of school programs, personnel, and services, and the reductions of school district reserve funds;

Whereas: Efforts by the Edwards-Knox Central School to sustain programs and services and contain budgets are simultaneously constrained by Property Tax Cap Legislation, unfunded and underfunded mandates, state mandated increases in pension costs, and mandated implementation of Common Core Learning Standards and teacher/principal performance reviews; and

Whereas: State Funding is constitutionally mandates and essential to meet all mandates and obligations to maintain the quality of education in the Edwards-Knox Central School; and

Whereas: New York State touts recent aid increases as generous support to schools, although overall, school districts are receiving very little additional aid when compared to 2008-09; and

Whereas: Some school districts have even experienced state aid decreases from 2008-09 to 2014-15;
