Mrs. Sykes also noted the Business Teacher opening and looked to the board for suggestions. Mrs. Sykes stated there has been a parent request of a 7th grade student wishing to skip 8th grade and move directly to 9th grade. Mrs. Sykes also stated her concern regarding students graduating early causing changes in student rank, Mrs. Sykes noted she will look into this process.

Ms. Hughes reported that the K-6 award ceremony went very well with a great turnout. Ms. Hughes also noted that Mrs. Daniels has done a very nice job with the reading area in the library. Thompson Zoo Park presented Birds of Prey for elementary students on Friday, Ms. Hughes reported that this was a very affordable and educational presentation. Ms. Hughes reported the upcoming delayed start on May 23rd with Cougar Day in the afternoon. Ms. Hughes also noted Kindergarten screening is next week and several elementary teachers will be traveling to Lockport for iPad and Chromebook training.

Mr. Merritt stated his concern with the baseball field drainage system and noted that Jeff Ramano from Appel Osborne Landscape Architecture will be on site next week. Mr. Merritt noted his concern with the low student interest in modified volleyball and modified soccer, Mr. Merritt stated he would like to retain both teams. Mr. Rob White will be looking into this for a possible solution. Mr. Merritt stated a meeting will need to be scheduled to finalize construction bids for Phase 2A of the construction project. Board Members agreed and noted that an unscheduled meeting will be set for May 24, 2016 at 6:30 p.m. in the library.

Mrs. Phillips reported on the changes to the STAR rebate, anyone who purchases a new building will pay the full amount up-front with a full rebate after the purchase. The change will not impact current tax payers. Mrs. Phillips reported that more information will be coming.
