I can start Yesterday was a really amazing day. We had our celebration of students parade. I was overwhelmed with the number of staff that came. We had law enforcement, fire departments. And we delivered from nine in the morning until two o'clock in the afternoon, almost 2:00, lawn signs and embroidered blankets to our seniors 38 seniors roughly 100 miles +, throughout the district. It was really just such a positive event. We had our senior parent Tim White that was dressed in the cougar costume. And just it was so

nice to be able to see the pride that the community has in our our students and it was an all time career high for for me, that's for sure. We had meal pickup today and as I had shared earlier, there's about 20 more each time we have our meal pickups. We serve more meals to families. Sure, sure. So I initially see sought after a resource list. I like everybody else watched the news and saw that you know, Watertown, urban mission, a lot of other, you know, bigger cities or bigger, you know, I guess communities were doing a lot of outreach. And I thought you know, I wonder what was the purpose for our people, our community members, a couple of Facebook messages later, I was talking Monday morning with the director, United Way here in Northern New York, so generously put us in, you know, direct con., you know, direct, I guess distribution, I'll call it have some really essential items for our community. So we received 15 cases of toilet paper four very large cases of paper towels, several cases of hand sanitizer, diapers of every size, formula, baby wipes. We distributed 126 packs of toilet paper. To there, we kind of did pre pre done bags with toilet paper, paper towels and hand sanitizer in them. And we tried to hit almost every family we gave a lunch to each household. We try to get a bag to them. We did run out a few hours before of the toilet paper and paper towels. But we continued to hand out the diapers and wipes and it seemed to be a really appreciated resource. I'm hoping that we can do that again and continue each week to support the families especially that you know might need a little bit of extra right now, especially in the diaper and the wipe department. and I just wanted to share some important end of year dates as well. Backwork will will be due for from students on June 8 and June ninth we are going to have student pickup of personal belongings and return of library books and textbooks. That's June 9 from nine until five. And our seven through 12th grade students will enter through the cougar entrance and our pre K through six students are going to enter in the front entrance we'll keep it very limited the number of students entering at that time. grades are due on June 11. The last day of school for our students is that Friday, June 12. Our last day for our instructional staff is on June 15 that Monday and on June 18 we will have our pre K

through 12 report card and awards picked up from eight until three. And this is a great segway. We are anticipating having graduation on June 27 at 11 o'clock and really hope to be able to have a special ceremony. It may be uniquely different, but we're hopeful that, you know, we can plan something as traditional as possible. So that leads me to Mrs. Sykes who has come up with four different options for graduation.

So, last Friday, I met with the seniors in a zoom meeting to explain to them the options that I feel that we have before us in preparation for graduation. The first option would be the optimum. That would involve a gathering where students would be able to invite parents and family we plan to have and host the ceremony outdoors, which I think everyone here is probably aware of ceremony will be outside with guests invited and students participating in an in person ceremony at exactly the same time, same place we expected minus the fact that we'd be outside that ceremony would be livestreamed. We're working on trying to connect with BOCES for support with that to make sure that the ceremony will be streamed no matter what circumstances we're in, and would be outdoors with students allowed us specific number of guests but of course, this is all under the prerogative of a number of people that we can have in a gathering. The great news is that phase four is scheduled to begin the day before our ceremony so that potentially although I'm not so sure that we're really impacted, I like to think that it would, students are well aware that that the options that I'm posing to them are all based on a gathering limitation. option two would be students would still be participating in the ceremony, parents would be invited to the staging area. When their child is scheduled to receive their award step slash diploma, this parents would be waiting in the parking lot. We would have a radio system so that the parents would come up, be able to watch their child go across the stage. So imagine all the students seated under a tent, we have a massive tent, they'd be seated alphabetically facing outward, parents would be asked to come up so they could witness their child going across the stage. option three would be if we are limited to a gathering of no more than 10 people or something in that vicinity. In that case, students and their families would be staged in the parking lot. We would still run our traditional ceremony through all of these minus the flower ceremony, possibly but definitely no slideshow. students would come up with their parents as they were participating in certain parts of the ceremony depending on for instance, if it was the speech, that student would come up to the stage for their speech, go back to the their vehicle to wait there, whatever next portion of the ceremony they participate in. When it's time to go across the stage again to get their awards and ceremony students and parents could come across and the parents would be able to observe their child receiving their awards and diploma. option four is everyone's least favorite in our graduation committee. And that would be a virtual ceremony where we are absolutely hoping that option one

two or three again and outdoor ceremony streamed with students participating live would be you know what, what we're hoping to move forward with one of the nice features that we're we're able we think we're going to be we know we'll be able to incorporate this but we're not exactly sure of the layout yet, students would be in this massive tent between the two fields out in the back lawn between the soccer fields staged around the x, just under the outside of the tent or actually under the edge of the tent facing out. In that area where the student is seated on the lawn, there would be a quadrant where that student's family would be staged. If we're able to have guests attend that portion, that quadrant on the lawn their families could decorate, put signs, if they're able to attend the ceremony, they could provide their own tent for themselves bring their own seating. And each family would have a section marked around the entire perimeter of the tent near where their graduate is located. That would be again those quadrants would be there no matter what which option we were having. But if we're allowed to have guests, those spaces will be there for guests. We're going to prepare our program and our ceremony so that it will accommodate no matter what ceremony we're at, hopefully, one, two or three, so that we're able to have that ready to go before the end of the school year. As you can imagine, it's the last day for staff and students is June the 15th. But graduation isn't until the 27th we need to make sure everything is or most everything is prepared and ready to go in a very short timeframe. So the good news is, we're really hoping that we're going to be able to have a ceremony where our students will be able to participate on our campus in some form, so that they will be here having that experience together, although maybe not necessarily all seated under the tent together, but I certainly that's, that's really my number one priority. I hope is for you know, obviously everyone to be there. But especially for the kids to be able to attend with each other. But that's really all going to be driven by any decision about a gathering size. That's really beyond the normal focus of instruction that's going on, which is really my priority right now. We are having, we'll have our third graduation committee meeting this Friday. And I met with the kids last week. I will certainly schedule meeting with parents as well. Once we have some clarification, or we hope to have more clarification on more about the ceremony, so but I'm telling the students and I'm telling everyone, right now, we don't know which option we're at. We're trying to hold off the latest possible so that we can have the best ceremony that we can put together for our students. Anyone have any questions? That's it for me.

So so those are still preparations that we need to make now. hopefully hopefully being able to get our pre-ker's to be able to come in and see the building before they're brought to school on the big yellow bus. So in general, there's there's just a lot of modifications. You know, we're, we're, the teachers have been very accommodating parents students it's it's really been a huge learning curve for everybody all across the board but we're getting there for sure. Okay, so you all received two different formats of the budget that we sent along the summary format and the line by line. As I mentioned previously, the budget Finance Committee met last Thursday to go through the budget line by line and discuss any areas. The overall budget that we are going to be putting out to the community. This for this year comes in at \$111,731 less than the current budget and I think we can, I know we can attribute a lot of that to the health insurance savings, the decrease that we'll see in that line where we will be appropriating 100 overall \$129,131 more for 2021 than we did for 2019/20. To make up for that reduction, that initial reduction in foundation aid that we had that we know so far again, as I had mentioned, we were going out with the runs from the stated runs that were released in April, the budget finance committee will meet again to come up with backup scenarios or backup drafts to reflect any scenarios with regard to state aid cuts. So a foundation aid cut with 3% 5% 10% where are those areas that we want to look at first and reducing as I mentioned previously, we're in good shape and where, where I don't see even with a three or 5% reduction, any any changes or reductions in a program personnel area, we just are held our fund balances strong and healthy. So even if we do receive, if there is a cut, I think we have movement to increase how much we appropriate for our fund balance. As I mentioned before, we do have a good chunk of savings this year from the health insurance switch. So that is money that will be going back into the fund balance that we feel comfortable if need be to re appropriate that for for next year if if those cuts do come to fruition. We'll go into more detail next week when we do the budget hearing. So again, that'll be next Tuesday. Again streamed and we got Facebook working so we should be all set. To get some, maybe some interaction with that. Any other specific questions about the budget? It does come in total at 15,999,299. So under the 16. I also want to note, we are still going out with that zero percent tax levy increase, which I think is key and important. And again, we'll make that up with some fund balance. appropriation.
