LETTER OF CONFIRMATION

Based on conversations with your school district, this letter confirms the Edwards-Knox Central School District requests the New York State School Boards Association to conduct an in-person Custom Board Retreat (CBR) for the Board of Education and Superintendent. The topics will concentrate on the roles and responsibilities of school board members and the superintendent, and a review of the board operations survey results. - 2) Have you tested positive for COVID-19 in the past 14 days?
- 3) Have you experienced any symptoms of COVID-19 in the past 14 days? (Symptoms include the following: cough, shortness of breath or difficulty breathing or at least two of these symptoms: fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, new loss of taste or smell).

The COVID-19 questionnaire (as seen above) must be administered by your district on the morning of Tuesday, September 21, 2021.

The fee for this CBR is \$2000. NYSSBA will send an invoice to the district after the program has been completed. Your receipt of this letter and your returning a signed copy of it to us will be deemed acceptance of its provisions unless you notify our office otherwise. (Notification must be made no later than 72 hours prior to 9/21/21. The district will be responsible for the full retreat amount should the event be cancelled after this time.)
